## SCOTT COUNTY COUNCIL

## **JULY 17, 2018**

The Scott County Council met in Executive Session on July 16, 2018 at 9:00 am in the Commissioners Room, Suite 128, Courthouse for the purpose of discussion of Safety and Security measures as allowed by I.C. 5-14-1.5-6.1(a)(1)(b)(3).

The Council members present were Mike Zollman, Chris Albertson, Iva Gasaway, Eric Gillespie, Robert Peacock, and Donnie Richie. Also present were Attorney Mike Carter, Chief Deputy Auditor Teresa Vannarsdall, and Auditor Tammy Stout Johnson. Council member Ab Watts was absent from the meeting.

## **REGULAR SESSION**

## SCOTT COUNTY COUNCIL

## **JULY 17, 2018**

The Scott County Council met in Regular Session on July 17, 2018 at 9:30 am in the Commissioners Meeting Room, Suite 128, Courthouse. Those present were Council members Donnie Richie, Eric Gillespie, Chris Albertson, Iva Gasaway, Robert Peacock, and Mike Zollman. Also present were Attorney Mike Carter, Chief Deputy Auditor Teresa Vannarsdall, and Auditor Tammy Stout Johnson. Council member Ab Watts was not present for the meeting.

The meeting was called to order by Zollman and opened for public comment. Guy Townsend announced that he, the Council's former appointment to the Alcoholic Beverage Commission, had recently been appointed to the State ABC Advisory Council. Gasaway congratulated Townsend on his appointment.

## JACKSON COUNTY REMC TAX ABATEMENT REQUEST & RESOLUTION

Jackson County REMC representatives Jerry Kelley and Mark McKinney explained the new internet service will be a division called Jackson Connect of the non-profit, member owned utility.

The service will be a true broadband fiber optic connection. The minimum package for \$54.95 monthly would have a speed of 50 Megs upload and download. Prices increase with connection speed options. JCREMC estimated it could serve 4,000 accounts. This service will fill the void of reliable internet in several rural areas. This will have an impact on agriculture as well because GPS is common equipment on combines.

The project is very capital intensive. The request was for a ten (10) year, 10 % graduated scale abatement on the improvements associated with the new internet service installation. McKinney also stated the installation and router will be offered for free during the initial phase build out.

**MOTION:** Albertson motioned to approve the Abatement Resolution (#2018-003) for Jackson County Rural Electric Membership Corporation that provides for a ten (10) year, 10% graduated scale abatement for broadband utility installation. Second provided by Richie. Motion carried unanimously.

MOTION: Albertson motioned to approve the abatement and sign the resolution for the Jackson County REMC (Jackson Connect) broadband internet service equipment. Second provided by Peacock. Motion carried unanimously.

## **SHERIFF PENSION PLAN TRUSTEE CHANGE**

Sheriff Kenny Hughbanks was unable to attend this meeting and no action was taken.

## **JAIL ELEVATOR REPAIR CLAIM**

Vannarsdall presented a claim in the amount of \$843.75 for repair work on the Jail elevator performed by Thyssenkrupp. Gasaway suggested the \$844 be included in the Custodian's budget transfer request. See next section.

## **CUSTODIAN TRANSFER REQUEST**

A transfer request was presented for the Custodian's budget. The amounts were as follows:

Janitor Supplies (25300) in the amount of \$629.05; Clean of Floors/Windows/War Memorial (30903) in the amount of \$1,050; Travel Expense (31300) in the amount of \$300; Encumbrance for Maintenance (35000) in the amount of \$6,871.75 & \$844 additional for the Elevator Claim; Heat Pump (42101) in the amount of \$1,250 for a total amount of \$10,945 to line item Maintenance Contracts (37001) for the transfer request.

MOTION: Peacock motioned to approve the \$10,945 transfer into the Maintenance Contracts (37001) line in the Custodian's budget from the lines and amounts as listed above. Second provided by Gasaway. Motion carried unanimously.

## SALARY ORDINANCE AMENDMENT

The proposed amendment to the 2018 Salary Ordinance reflected the changes to the number of and compensation for Elections workers as requested by the Clerk at the June meeting. The amendment also captured the addition of the part time Deputy for the Sheriff's Office (maximum \$6,000 expenditure).

**MOTION:** Peacock motioned to approve the amended 2018-001 (A) Salary Ordinance. Second provided by Gasaway. Motion carried unanimously.

## **MISCELLANEOUS**

Vannarsdall reminded the members that the all day budget review would be held on their regular meeting day, August 21, 2018 from 8:30 am-4:30 pm.

The Budget adoption meeting was scheduled for 8:00 am on the days of October 9 and 10 with adoption day set for October 11, 2018 at 9:00 am.

Zollman stated he was pleased that no additional appropriations had be made to date from General Fund and that efforts have been made to reduce the 2018 spending.

## **SPECIAL SESSION**

## **JULY 24, 2018**

The Scott County Council met in Special Session on July 24, 2018 at 1:30 pm in the Commissioners Room, Suite 128, Courthouse. A recent merger between MainSource Bank and OneAmerica created a reduction of staff and the trustee department was eliminated. The new bank, CoMerica, will serve as and be the designated Trustee. Beatty informed the Board that new trust agreements will be prepared for the approval of Council, Merit Board, and the Sheriff.

**MOTION:** Watts motioned to approve CoMerica as the new Sheriff's Pension Plan Trustee. Second provided by Gasaway. Motion carried unanimously.

Sheriff Hughbanks updated the Council on an amendment to the Sheriff's Retirement Plan (Second). The changes included a requirement for those leaving before age 55 to have eight (8) full years of service or there would be no benefits. The complete amendment was provided to the members. Hughbanks informed the Board that Officers and the Merit Board voted in favor of the amendment. Gasaway suggested taking the amendment under advisement.

## **BOARD OF ZONING APPEALS APPOINTMENT**

The final appointment to the newly formed County Board of Zoning Appeals was considered by the Board.
