### **CALL TO ORDER**

### **OLD BUSINESS**

• Log Jams – President, Everitt Hunley, stated that all seven (7) log jams in Austin are completed. Jackson Co has agreed to use the rest of the money to fund the log jams in Peacock Bottoms and on Crothersville Road Bridge.

#### **NEW BUSINESS**

- <u>Issuing Drainage Permits</u>...Board is not issuing permits until we receive funding from Stucker Ditch maintenance project. Everett Hunley and Bill Comer will talk to Roger Hawkins and hopefully Tyler Peterson to ask the importance of the drainage permits and how to track those, with Everett Hunley to set up that meeting next week.
  - Dollar General Project out by Pioneer Village is out due to the denial by the Scott Co. Commissioners vote.
  - Dollar Tree Project on Main Street in Austin has not gotten a drainage permit.
- <u>Stucker Ditch Project</u>...Mike Jones has requested 2 million dollars on the Stucker Ditch Project from the Readi 2.0 grant. Board to investigate what needs to be done to be prepared for that grant.
- <u>USDA Funding</u>... It is understood that funding from the USDA in the form of a loan isn't going to be available. It is possible that if we have a project in connection with Stucker ditch, we MIGHT be able to get that funding. The board might need to have a meeting with Terry Goodin to see if he can speak with the Corp. of Engineers about that funding.
- Representative... Chip Perfect was representative for Austin and Lawrenceburg resigned, and Randy Maxwell won the caucus and was appointed. Board member Mark Gardner had spoken to Mr. Perfect, and he was checking into how the State could help with the drainage board. And now the board should reach out to new representative Randy Maxwell.
