

**REGULAR SESSION**  
**SCOTT COUNTY COUNCIL**  
**APRIL 13, 2020**

The Scott County Council met in Regular Session on April 13, 2020 at 9:30 am in the Commissioners Room, Suite 128, Courthouse. Those present were Council members Mike Zollman in person with other members attending by conference call were Donnie Richie, Ab Watts, Robert Peacock, Iva Gasaway, and Raymond Jones. Also present were Attorney Mike Carter (phone) and Auditor Tammy Stout Johnson (in person). Council member Rachael Hardin was absent from the meeting.

The meeting was called to order by Chairman Zollman who opened the meeting with roll call. Zollman thanked IT Andrew Campbell for setting up the call in conference meeting for COVID-19 safety measures.

**PANDEMIC PAY AMENDMENT (#2020-003) TO 2020 SALARY ORDINANCE**

In anticipation of a statewide declaration of a public health emergency, Commissioners passed an amendment to the 2020 Salary Ordinance #2020-003 on March 18, 2020. The ordinance was for compensation allowance to non-essential employees that may be performing job functions from home or have "on call" status if the County buildings were closed or had limited access in a statewide stay at home emergency. The Governor did announce a stay at home order effective March 25, 2020 which was amended to April 20, 2020. The date span of Ordinance #2020-003 was from March 25, 2020 through April 18, 2020.

**MOTION:** Peacock motioned to approve the amendment to the 2020 Salary Ordinance #2020-003 to allow for payment of regular wages to employees from March 25, 2020 to April 18, 2020 whether working on site, working remotely, or in "On Call" status. Seconded by Richie. Motion carried unanimously.

**PROPOSAL OF ADDITIONAL COMPENSATION DURING OF PANDEMIC CLOSING**

President Zollman asked members their thoughts on additional compensation for those employees required to work on-site during the period between March 25, 2020 and April 18, 2020. It was by consensus that members agreed to discuss the proposition of additional benefits at the May meeting.


**CONSIDERATION OF MINUTES FROM MARCH 10, 2020 MEETING**


Minutes from the March 10, 2020 meeting were presented for consideration and approval.

ADJOURNMENT




